COMMENTS BY APPLICANT: Patricia Zanghi stated the purpose of this fence is to hide the garbage/junk on her neighbor's property. Additionally, her neighbor has a dog that runs loose and is not friendly. She wants to keep the dog from coming on her property.

COMMENTS BY PLANNING BOARD: Harold Smith, Chairman read the Town of Portland Ordinance, Article 800, Section 816, Subsection A2 - Fence/Walls. It was established that the fence would be approximately 96 ft. in length. The fence would be constructed of pressure treated wood, 4 x 4 posts, which must be 42" in the ground. Harold stated that the fence must be 2 ft. off the property line and 10 ft. off the road right-of-way.

- 1. Said fence shall be placed a minimum of 2 ft. off of all property lines.**
- 2. All fencing shall be installed per description contained in the estimate prepared by Paradis Fence and Flag, Inc. dated 5/8/2017. Said fence shall be maintained in substantial condition and in good repair. Failure to do so shall require removal of all fencing addressed by this Special Use Permit. The pressure treated wood fence shall have the finished side facing the neighbor's property.**
- 3. Said fence shall be 10 ft. off the road right-of-way.**
- 4. All construction must comply with applicable building codes of the Town of Portland and the laws of the State of New York.**
- 5. Any concerns must be addressed with the Code Enforcement Officer.**
